Any written documentation supporting the entries reported in the account books, indicating the transaction's accounting accuracy, can be referred to as a voucher. For example, a bill, invoice, receipt, salary and wages sheet, pay-in-slip counterfoil, cheque book counterfoil, or trust deed.

A voucher is a redeemable form of transaction bond that is worth a particular monetary value and can only be used on specific grounds or specific goods. Examples of this include vouchers for lodging, transportation, and food.

# **Accounting Voucher**

A voucher is created once we have received the invoice from a supplier. It has to be stamped as

"paid" when a cheque or digital payment is made to a supplier and is then archived along with any supporting documents.

A mechanism called a "payment run" is performed in account payable systems to produce

payments that correspond to the unpaid vouchers. The voucher can be used in accounts

receivable to adjust an account. Also, the voucher can be used to adjust the accounts under

general ledger, and it is called as a journal voucher.

# **Components of Voucher**

This is most commonly found in a manual payment scheme, in which it is part of

the control mechanism. A voucher usually contains the following information:

- **Supplier identification number**
- The amount payable
- **The date on which payment will be made**
- **The accounts payable to record the liability**
- Any valid early payment discount terms
- **The approval signature or stamp**

# **Benefits**

The following are a few benefits of maintaining vouchers:

- ✤ Vouchers are useful to retain better control over the payables process.
- Many invoices can be paid at once, thereby reducing the number of cheques.
- It can be pre-numbered and simplifies the payables audit trail.
- Invoice approval is segregated from invoice payment, both for optimising productivity, making it

easier to plan.

Collection of invoices shall be made by the cashier, who shall report to the treasurer.

#### Internal-Voucher:

These are the vouchers which are used for internal use of organisation, like for transfer of goods from one branch to another of the same organisation.

These also comprise of the vouchers which are prepared for some expenses for which no invoice or receipt is provided. It includes vouchers for auto fare, cab fare, purchase from hawkers, etc.

External-Voucher:

It is the document received from outside party for a business transaction.

It includes vouchers and receipts provided from the seller of shops like bill for stationery, electricity bills, receipt of rent paid, etc.

# **TYPES OF VOUCHERS**

## (i) Receipt Voucher:

A Receipt voucher is used to record cash or bank receipt. Receipt vouchers are of two types which are as follows:

(a) Cash receipt voucher – it denotes receipt of cash in hand.

**(b) Bank receipt voucher** – it indicates receipt of a cheque or demand draft i.e. money is not received in the form of cash in hand, instead, the money will be credited to the bank account of the assessee.

## (ii) Payment Voucher:

A payment voucher is just the opposite of a cash voucher. In the above, cash/ bank was debited, while in this case, cash or bank will be credited. In the above case, there was an inflow of funds, while in this case, there is an outflow of funds. A Payment voucher is used to record a payment of cash or cheque. Payment vouchers are also of two types which are:

## (a) Cash Payment voucher – it denotes payment of cash

**(b) Bank Payment voucher** – it indicates payment by cheque or demand draft i.e. money is not paid in the form of cash in hand, instead, the money will be debited from the bank account of the assesse

#### (iii) Non Cash Or Transfer Voucher or Journal Voucher:

These vouchers are used for non-cash transactions, they are basically used as a documentary evidence. e.g., Goods sold on credit. In such cases, the cash or the bank account of the assessee is unaffected. In the case of Goods sold on credit, the Voucher would debit the Debtor to whom the goods are sold on credit, while sales on credit account would be credited further.

#### ( iv ) Supporting Vouchers:

These vouchers are the documentary evidence of transactions that have happened. For example, you can attach the bill of an expense along with the original voucher just to further support the primary voucher. Petrol Bills attached with the conveyance vouchers are a good example of Supporting Vouchers.



# **Accounting Process**



## JOURNAL

► The word journal comes from the French word "Jour" meaning "day". It is a

book of original or prime entry written up from the various source documents.

Journal is a primary book for recording the day to day transactions in a

chronological order i.e. in the order in which they occur. The journal is a form of

diary for business transactions. This is also called the book of first entry since

every transaction is recorded firstly in the journal.

## IMPORTANT CONSIDERATIONS FOR RECORDING THE BUSINESS TRANSACTIONS

#### 1. Trade Discount

Trade discount is usually allowed on the list price of the goods. It may be allowed by producer to wholesaler and by wholesaler to retailer for purchase of goods in large quantity. It is not recorded in the books of account and entry is made only with the net amount paid or received.

#### For example

purchased goods of list price Rs. 8,000 at 15% trade discount from X. In this case the following entry will be passed :

#### 2. Cash Discount

Cash discount is a concession allowed by seller to buyer to encourage him to make early cash payment. It is a Nominal Account. The person who allows discount, treat it as an expense and debits in his books and it is called discount allowed and the person who receives discount, treat it as an income and it is called discount received and credited in his books of account as "Discount Received Account."

#### For example,

X owes Rs. 6,000 to Y. He pays Rs. 5,950 in full settlement against the amount due. In the books of X, the journal entry will be :

#### 3. Goods distributed as free samples

Sometimes business distribute goods as free samples for the purpose of advertisement. In this case,

Advertisement Account is debited and Purchases Account is credited.

For example,

Goods costing Rs. 8000 were distributed as free sample. To record this transaction following entry will be passed:

Advertisement Account Dr. 8,000

**To Purchases Account** 

8,000

#### 4. Interest on capital

Interest paid on capital is an expense. Therefore interest account should be debited. On the other hand the capital of the

business increases. So the capital account should be credited. The entry will be as follows:

Interest on Capital Account Dr.

**To Capital Account** 

#### 5. Interest charged on Drawings

If the interest is charged on drawings then it will be an increase in the income of business, so interest on drawings will be credited. On the other hand there will be increase in drawings or decrease in Capital. So Drawings Account will be debited. To record this, following entry will be passed:

Drawing Account/Capital Account Dr.

To Interest on Drawing Account

### 6. Depreciation charged on Fixed Assets

Depreciation is the gradual, permanent decrease in the value of an asset due to wear and tear and many other causes.

Depreciation is an expense so the following entry will be passed:

### **Depreciation Account Dr.**

**To Asset Account** 

### 7. Bad Debts

Sometimes a debtor of business fails to pay the amount due from him. Reasons may be many e.g. he may become insolvent or he may die. Such irrecoverable amount is a loss to the business. To record this following entry will be passed :

#### **Bad Debts Account Dr.**

**To Debtor's Account** 

#### 8. Bad Debts Recovered

When any amount becomes irrecoverable from any costumer or debtor his account is closed in the books. If in future any amount is recovered from him then his personal account will not be credited because that does not exist in the books. So the following entry is passed :

Cash Account Dr.

**To Bad Debts Recovered Account** 

#### 9. Purchase and Sale of investment

When business has some surplus money it may invest this amount is shares, debentures or other types of securities. When these securities are purchased, these are recorded at the purchase price paid. At the time of sale of investment the sale price of an investment is recorded in the books of accounts.

#### The following entry is passed to record the purchase of investment :

**Investment Account Dr.** 

**To Cash Account** 

In case of sale of these securities the entry will be :

Cash Account Dr.

**To Investment Account** 

## 10. Loss of Goods by Fire/Accident/theft

A business may suffer loss of goods on account of fire, theft or accident. It is a business loss and a nominal account. It also reduces the goods at cost price, and increases the loss / expenses of the business. The entry will be passed as :

Loss by fire/Accident/theft Account Dr.(for loss)

## Insurance Company Account Dr. (for insurance claim admitted)

**To Purchases Account** 

### 11. Income Tax Paid

Income Tax paid should be debited to Capital Account or Drawings Account and credited to Cash Account in case of sole proprietorship and partnership firms. The reason behind this is that income tax is a personal expense for the sole trader and partners because it is paid on income of proprietor. The entry will be as follows :

**Capital Account/Drawing Account Dr.** 

**To Cash Account** 

## 12. Bank Charges

Bank provide various services to their customers. Bank deducts some charges by debiting the account of customers. It is an expense for the business. To record this, Bank charges account is debited and bank account is credited in the books of customer.

### 13. Drawings Account

It is a personal account of the proprietor. When the businessman withdraws cash or goods from the business for his personal/domestic use it is called as 'drawings'. Drawings reduce the capital as well as goods/cash balance of the business. The journal entry is :

**Drawings Account Dr.** 

**To Cash Account** 

**To Purchases Account** 

#### 14. Personal expenses of the proprietor

When the private expenses such as life insurance premium, income tax, home telephone bill, tuition fees of the son of the proprietor etc. are paid out of the cash or bank account of business it should be debited to the Drawings Account of the proprietor.

#### 15. Sale of Asset/Property

When the asset of a business is sold, there may occur a profit or loss on its sale. Its journal entry is :

#### (i) In case there is a profit on sale of Property/Assets

Cash/Bank Account Dr.

**To Asset/Property Account** 

To Profit on sale of Asset Account

(ii) In case of a loss on sale of asset

Cash/Bank Account Dr.

Loss on sale of Asset Account Dr.

**To Asset Account**

## **Output Operator**

For displaying data on the standard output device the cout stream object is used. It is predefined object of the "ostream" class.

It is used with insertion operator "<<" which inserts data into the output stream. Syntax

cout<<data;

The << operator is known as insertion operator since it inserts the data that follows it into the stream that precedes it.

The data to be inserted into the output stream can be a variable name, constants or an expression.

Examples

cout<< "hello";

cout<<a+b;

cout<<factorial(n);</pre>

## **Input Operator**

The standard input stream object is cin which is used to read data from a standard input device like keyboard.

It is predefined object of the "istream" class.

It is used with extraction operator ">>".

This must be followed by the variable name that will store the value being read from the stream.

Syntax

cin>>variable;

The operator >> is known as get from operator or extraction operator.

Example cin>>n;

### **Reference Variables**

- > Reference variable is a new name given to an existing variable.
- > It provides an alias (alternative name) for a previously defined variables.
- > Syntax

datatype & reference variable name = variable name

- Example :- int total=100; int &sum=total:
- > A reference variable must be initialized at the time of declaration. This establishes the correspondence between the reference and the data objects which it names.
- > When we create a reference variable, we are not creating a new variable, that is no memory is allocated to the reference variable.
- > The original name and reference name both refer to the same memory location.
- $\blacktriangleright$  The value can be accessed using both, the original variable name as well as reference name.
- > The value can be changed using either the original name as well as reference name.
- > If any one of the two variable change than it will affect the other.

C++ has a rich set of operators. All C operators are valid in C++ also. In addition to that C++ introduces some new operators. We have already seen two such operators namely, the insertion operator <>. Other new operators are:

#### **Scope Resolution operator**

C++ is also a block structured language.

Blocks and scopes can be used in constructing program

Same variable name can be used to have different meaning in different blocks. The scope of the variable extends from the point of its declaration till the end of the block containing the declaration

A variable declared inside a block is said to be local to that block. int x:

Block 2 is contained in block 1. Declaration in inner block hides a declaration of the same variable in an outer block and therefore each declaration of x causes it to refer to a different data object.

In C the global version of a variable cannot be accessed from within the inner block.

C++ resolves this problem by introducing a new operator :: called the scope resolution operator.

Syntax	
:: variable name	

This operator allows access to the global version of a variable.

In the above program , the variable m is declared at 3 places namely outside the main() function, inside the main() and inside the inner block.

#### Memory management operator (new, delete)

- C uses malloc() and calloc() function to allocate memory dynamically at runtime. Similarly it uses the function free to free dynamically allocated memory.
- We use dynamic allocation technique when it is not known in advance how much of memory space is needed.
- C++ also supports these functions but it also defines two unary operator new and delete that perform the task of allocating and freeing the memory in a better and easier way.
- Since these operators manipulate memory on the free store, they are also known as free store operator.
- An object can be created by using new and destroyed by using delete as and when required.
- A data object created inside a block with new, will remain in existence until it is explicitly destroyed by using delete.
- > Thus lifetime of an object is directly under our control.
- > The new operator can be used to create objects of any type
- Syntax: pointer variable=new data type
- Here pointer variable is a pointer of type data type
- The new operator allocates sufficient memory to hold a data object of type datatype and returns the address of the object.
- > The data type may be any valid data type.
- > The pointer variable holds the address of the memory space allocated.
- Example :- int \*p;

float \*q; p=new int; q=new float;

p is a pointer of type int and q is a pointer of type float.

p and q must have already been declared as pointers of appropriate types.

We can combine the declaration of pointers and their assignments as follows: Example :- int \*p=new int;

float \*q=new float; \*p=25; \*q=7.5

This statement assigns 25 to the newly created int object and 7.5 to the float object

We can also initialize the memory using the new operator. This is done as follows.

**Example :-** int \*p=new int (25);

float \*q=new float(7.5);

- new can also be used to create a memory space for any data type including userdefined type such as arrays, struct and classes.
- Syntax:- pointer variable=new data type [size];

Size specifies no. of elements in an array.

**Example:-** int \* p=new int [10];

This creates an memory space for an array of 10 integer.

- P[0] refers to first element.
- P[1] refers to second element and so on
- When creating multi-dimensional arrays with new, all the array sizes must be supplied.

int \*p = new int [3][5][4]; //legal int \*p = new int [3][5][]; //illegal

#### Delete

- When a delete object is no longer needed, it is destroyed to release the memory space for reuse.
- Syntax:- delete pointer-variable;
- The pointer-variable is the pointer that points to a data object created with new. Example:- delete p;
- If we want to free a dynamically allocated array we must use the following form of delete

Syntax:- delete [size] pointer variable;

 $\blacktriangleright$  The size specifies the no. of elements in the array to be freed.

#### Advantages of the new operator over malloc() function

- It does not use the sizeof() operator as it automatically computes the size of the data object.
- It automatically returns the correct data type pointer, so does not need to use the typecasting.
- It allows to initialize the data object while creating the memory space for object.
