## CODE OF POLICY CONDUCT FOR STUDENTS

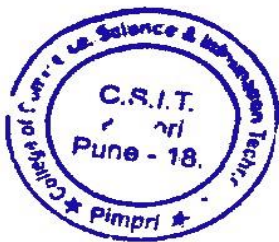
